

## **Nature of business and Items permitted**

- Book Stall & Stationery**     a) News Papers  
b) Weekly, Fortnightly and Monthly magazines  
c) Books ( prohibited books/ Magazines shall not be sold)  
d) Pens/ Pencils  
e) Dairies, Calendars etc.  
f) Stationery items viz: pens, pencils, tags, file pads, gum, plaster etc.
- Mobile Stall:**     Mobile phones, Cases & Covers, Screen Protectors, Power banks, Bluetooth Headsets, Wired Headsets, Data Cables, Chargers, Mobile utility/ antivirus software.
- Fancy & Gen:**     Plastic/Rubber Goods, Bags, Ladies Purse/Verity Bags, Soaps, Talcum Powders, Small Mirrors, Decorative Paper Items, Photo Frames, Bangles, Trays, Toys, Cosmetic Items/Detergents, Shaving Cream/Lotions, Combs, Tooth paste/Brush, Flasks, Rold Gold fancy Items, Photo Albums and Shampoos.
- Bakery:**     Biscuits, Bread, Khara, Chips, Cakes, Jam, Readymade baked Food items and Chocolates with a permission to use an electric oven.
- Cool Drinks:**     Already manufactured and stored drinks in bottles/pockets (Company drinks) such as Limca, Thums up Gold Spot, Pepsi, Coca Cola, Maaza, Frooti etc.,. b) Sodas in sealed bottles manufactured by reputed Companies like Bislery, Kinley etc.. (Water Bottle not permitted)
- Sweet Stall:**     a) All kinds of Sweet items b) All kinds of Savory (Khara) Items
- Popcorn:**     Popcorn only ( Fryms not permitted)

**Tea & Snacks:** **A)** Tea and Coffee shall be served in disposable cups. And **B)** i) Any fried and packed eatables which doesn't require heating or warming at the time of sale. ii) They should be packed in polythene wrappers or packets in ready to eat condition and should not be loosely stocked in open type vessels or tins. iii) The licensee shall not be permitted to have a Stove/heating point in the Stall for preparation of Snacks.

**Fast Food: Center** Tiffin items – Idli, Vada, Upma, Chapathi, Dosa, Vegetable Biryani, Curd Rise, Lemon Rise, Mysore Bajji, Tamato Bhat, Poori, Pakoda, Dahi Vada and Utappa. b) Tea Coffee, Milk, Butter Milk, Bournvita, Boost, Maltova and Horlics.

**Tea & Tiffins:** Tea and Coffee are permitted and shall be served in the disposal cups. Idly, Wada, Dosa, Upma, Mysore Bajji and Poori etc. only.

**Fruit Stall:** All kinds of Dry Fruits and fresh Fruits such as Banana, Apple, Orange, Grapes, Mangoes & Pine apple etc., The licensee shall not allotted to sell fruit juice.

**Panshop:** Pan and pan related items, Tobacco products shall not permitted.

**Stationery & Xerox**

- a) Books ( prohibited books/ Magazines shall not be sold)
- b) Pens/ Pencils
- c) Dairies, Calendars etc.
- d) Stationery items viz: pens, pencils, tags, file pads, gum, plaster etc.
- e) Taking of all sizes of Xerox.

**Flower Stall:** Flowers – Garlands.

**Coconut Bondam:** Coconut & coconut Bondams

**Saloon:** Saloon/Barbar shop only
