I. Sealed Tenders in the prescribed form are invited from the experienced and interested parties for participating in Tenders for re-furbication of re-furbishing of SLF removed sets of seat frames consisting of 44 seats per bus for 15 to 25 buses per month on JNNURM buses at Bus Body Building Workshop: Miyapur by providing Male Labour.

1) **JOB DESCRIPTION:**

- i) Dismantling of seat back & bottom from frame
- ii) Dismantling of seat plastic mould from M.S Frame
- iii) Cleaning and attending of damages to frames
- iv) Repainting of seat frame, plastic mould
- v) Replacement of damaged rexine/ fabric of seat back & seat bottom with new rexine
- vi) Fitment of back & bottom, plastic mould to seat frame

The above works are to be carried out as per the drawings, designs and specifications given by TSRTC. Necessary Tools and infrastructural facilities required for fabrication will be provided by the TSRTC.

2) **Period of Contract:** Two Years and extendable by one more year.


3) **E.M.D.** to be paid is **Rs.10,000/-** (Rupees Ten Thousand only)
