Tender Forms duly filled in all respects together with the Demand Draft for an amount of **Rs.30,000/-** (Rupees Thirty thousand only) towards Earnest Money Deposit (EMD) drawn in favour of "FA & CAO, TSRTC, MUSHEERABAD, HYDERABAD" in a sealed cover should be dropped into the Tender Box on **09.12.2020** by 14-00 hrs provided at the Conference Hall of TSRTC Hospital, Tarnaka, Hyderabad.

The Tenders will be opened at 15-00 hrs, on the same day i.e, **09.12.2020** in the Conference Hall of TSRTC Hospital, Tarnaka in the presence of Tenderers or their authorized representatives. Without authorization, others are not allowed.

The Tenders received after due date and time or Tenders not accompanied with the Demand Draft for requisite EMD amount or EMD amount being paid is less than **Rs.30,000/-** or Tenders in the name of minors will not be accepted. The EMD amount will not carry any interest.

JOB DESCRIPTION FOR PEST CONTROL TREATMENT IN RTC HOSPITAL, TARNAKA, HYDERABAD.

1. All General Wards / Labs. / Theatres / Garden / Quarters / All O.P.Blocks and open area etc. Pest Control Activity vi., Flying / Fly control / Mosquitoes Control / Silver Fish / Moths / Spider / Bed Bugs / Ants and other harmed Germs. – Daily.
2. General Wards – Debugging Control, Spraying including Lockers / Beds / Benches / Tables and Chairs. – Daily.
3. Rodent Control in the premises of Hospital.
4. Fumigations of Operation Theaters – Weekly once.
5. Fogging operation to be carried out surroundings and hiding places to stop further migration of Mosquitoes and other Germs – Thrice in a Week.
6. TIMINGS - From : 01-00 pm to 08-00 pm or mutually agreed daily schedule / Time Table with One Well Trained Operator followed by Supervisor visit from time to time.

**NOTE:**

1. The Superintendent&CMO/TH, TSRTC Hospital, Tarnaka reserves the right to reject the issue of tender schedule and also to reject for tender schedules without assigning any reason whatsoever.
2. Tender Schedule will be issued either to the intending tenderers or to their authorized agents by from **09.30 AM and 16-00 PM from 23.11.2020 to 08.12.2020** in the PO's Office, TSRTC Hospital, Tarnaka, but will not be sent by post.
3. Conditional Tender will not be accepted.
4. Finalization of Tenders will be by way of negotiations by the Tender Committee with each of the tenderers and decision of the Tender Committee in this regard shall be final.
5. The EMD is not exempted to any society / voluntary organization / institutions / communities / individuals etc.
6. If the tenderer fails to submit the following copies of documents mentioned below, the tender form / application will be rejected.
  - (a) PF Code Number
  - (b) ESI Code number
  - (c) GST registration
  - (d) Firm registration

- 7. No employee presently on rolls of TSRTC allowed to be a partner either directly or indirectly to the applicant.
- 8. The track record of firm/contractor should be good and he should not have any involvement in any illegal activities or frauds and those who are under black list are not allowed to participate in tenders.
- 9. The firm/contractor shall not engage any persons whose character and credentials and integrity are doubtful in nature and those who are on the record of Police with criminal background. If any such persons are engaged, the contractor/firm is solely responsible for such engagement and he is responsible for all the consequences that may take place during the tenure of his contract.
- 10. The firm/contractor shall be liable for all statutory payments in respect of contract services and his employees.
- 11. The Tenderer shall sign in all pages of Terms & Conditions of the Tender form; otherwise the tender will be rejected.
- 12. The Corporation has right to reduce/increase the man power during the agreement period.
