- a) The tender is for appointment of contractors for installation and operation of Person Weighing Machines/BMI (Body Mass Index) Machines in TSRTC Bus stations for a period of three years.
- b) Earnest Money Deposit for an amount of Rs 1,00,000/- (Rupees one lakh only) in the form of Demand Draft obtained in favour of Financial Adviser, TSRTC from any nationalized bank to be scanned and updated online.
- c) Before submission of the tender though online, tenderers are required to make themselves fully conversant with the eligibility, terms and conditions, so that no ambiguity arises at a later date in this respect.
- d) Corporation reserves the right to **accept any tender or reject/cancel any tender or all the tenders** received in response to this tender notification at any stage without assigning any reasons whatsoever.

TERMS AND CONDITIONS OF THE TENDER

General

1. Tenderer is required to read carefully the contents of this document and is expected to examine all instructions, forms, terms and conditions in the tender documents. Failure to furnish all the information required as per the tender document or submission of a tender not substantially responsive to the tender documents in every respect will be at the Tenderer's risk and may result in rejection of the tender.
2. The Tender must be submitted in the prescribed Tender Form along with requisite EMD.
3. The Tender form must be signed by the Tenderer only.
4. The Tender once submitted shall not be permitted to be withdrawn. The Corporation shall not be responsible for the delay in finalizing the tenders for administrative reasons or for the reasons beyond its control viz., Court directive etc.
5. **Any person/Agency/Organization, who/which was a contractor to the Corporation in the past and was terminated due to default in payment or for any other reason and any existing contractor who defaulted in payment of contract amount equivalent to 6 months and above in the present contract on the date of submission of this tender, is disqualified from participating in this Tender.**

Earnest Money Deposit

6. The EMD is Rs.1,00,000/-. The Tenderer shall submit a Demand Draft obtained from any Nationalized Bank/Scheduled Bank for the stipulated amount towards EMD. No exemption of EMD is allowed to any Government Organization/SSIs etc. The Demand Draft should be obtained in favour of FINANCIAL ADVISER, TSRTC, MUSHIRABAD, HYDERABAD. EMD in any other form other than Demand Draft will not be accepted.

Signature of the Tenderer

7. The tenderer shall also submit DD for an amount of Rs.5900/- towards Tender document Process fee.
8. The EMD will not carry any interest. The EMD of the unsuccessful tenderers will be refunded only after finalization of Tenders. The Corporation shall not be responsible for any delay in refund of EMD due to any reason in finalizing Tenders i.e., Administrative reasons / Court directive etc. The EMD of the successful tenderer will be adjusted towards security deposit payable to the Corporation.
9. The EMD of the tenderer will be forfeited under the following circumstances.
 - (a) When the EMD is not paid or less paid than what is stipulated in the tender.
 - (b) When the EMD is paid through other means i.e., in a manner other than what is stipulated in the Tender Notification.
 - (c) When Tender form with pre-conditions or additional conditions is submitted.
 - (d) When the tender is submitted in an unconcerned tender form.
 - (e) When the tender is submitted for the business other than that notified in the tender Notification.
 - (f) When the tender form is submitted by a minor. However, in case the tender is submitted on behalf of a minor, necessary proof of guardianship shall be submitted, failing which tender will be rejected.
 - (g) When the Tender form is submitted by the person as stated vide clause 5 above.
 - (h) When the tender form is rejected as per the clause 13.
 - (i) When the successful tenderer fails to pay the Security deposit within 15 days from the date of issue of letter of allotment of the contract.
 - (j) When the successful tenderer backs out from taking up of the contract within the stipulated period, for whatsoever reason.
 - (k) When the successful tenderer fails to enter into an agreement with the Corporation within 15 days from the date of issue of allotment letter for the contract.
 - (l) Non enclosure of requisite documents.

Submission of Tender:

10. Before submission of the tender, tenderers are required to make themselves fully conversant with the terms and conditions, so that no ambiguity arises at a later date in this respect.
11. If the tenderer finds discrepancies in tender document and its conditions or if he/she is in doubt as to their meaning, he/she should at once intimate and obtain clarification prior to submission of the tender.
12. If the tender is submitted on behalf of a firm, name of the person representing the firm along with designation shall be mentioned in the tender form below the firm's name. Also proof of authorization shall be enclosed.

Signature of the Tenderer

13. The tender form shall be filled in all respects and shall be signed by the Tenderer. The Tenderers should ensure that their offer is submitted on the **due date and time**.

Incomplete tenders or tenders not fulfilling any of the conditions specified above are liable to be rejected without assigning any reason.

14. The Hard copy of the documents must be submitted to the C T M(M&C) &DIR(CP), TSRTC, Mushirabad, Hyderabad -500 624, before 19.03.2020 at 02.00 pm or any Amendments issued thereon.

i) Documents required for qualification:

(a) A DD for Rs 5900/- towards tender document process fee.

(b) A DD for Rs.1,00,000/- towards EMD.

(c) Application form duly filled and signed as indicated at **Annexure - I**.

(d) All the papers of tender document with terms and conditions duly signed by the Tenderer on each page as a token of acceptance of all the terms and conditions.

(e) Self Attested copies of Tenderer's partnership deed/ proprietorship deed /Registration Documents, as applicable.

(f) Self Attested copy of PAN/TAN card of the Tenderer.

(g) Power of Attorney/Authority Letter to sign the Tender Document as applicable.

(h) Any other document required as per the tender conditions

15. The tender must be unconditional. Conditional offers will be summarily rejected. The tender shall be quoted by the Tenderer entirely in Indian Rupees. The Tenderer has an option to install more number of machines at the allotted bus station by paying the requisite Security Deposit amount, license fee, electricity charges etc., as finalized in the contract.

16. Corporation reserves the right to determine the maximum number of Person Weighing Machines/BMI Machines that could be installed in a particular Bus station.

The Tenderer shall have no right to insist for installation of more number of Person Weighing Machines than the number specified for each bus station.

17. The tenderer shall quote the monthly license fee payable per month per machine against the Bus stations. The list of Bus stations is mentioned at annexure-II. The amount offered shall be the net amount payable to the Corporation. The base price for each class Bus stations is furnished hereunder:

Class of Bus station	License Fee (in Rs.) Per Machine/Per Month
Major	1500
A Class	1000
B Class	700
C Class	500

The quote of the tenderer shall not be less than the (minimum) base price fixed, as above.

The Monthly License Fee per Machine will be enhanced @10% every year from 2nd year onwards over the previous year's license fee.

Signature of the Tenderer

Opening and Evaluation of Tenders:

18. The Tenders will be opened in the Corporate Office at 03.00 P.M., on 19.03.20 for technical evaluation and price bids will be opened at 03.00 pm on 23.03.2020.
19. The contract will be awarded to the highest quoted tenderer on the basis of highest license fee offered per each Bus station, after negotiations and recommendations made by Tender Committee constituted for this purpose.
20. Preference will be given to those tenderers who have more experience in the similar field, **provided other things being equal.** Necessary proof of experience shall be submitted.

Note: Even though the tenderers meet the requirements, they are subject to be disqualified at any stage if they have made misleading or false representations in the forms, statements and attachments submitted in proof of the requirements / qualification.

Tender Evaluation Committee

21. The Tender Evaluation Committee constituted by the Corporation shall evaluate the tenders. The decision of the Tender Evaluation Committee in the evaluation of the Tenders shall be final. No correspondence will be entertained outside the process of negotiation / discussion with the Committee.
22. The committee have the authority to review and take decision for finalisation of the license allotment, in case of previous default history in such business by the participating bidder.
23. Any approach from the tenderer's representative or his Contractor, trying to influence the decision on the tender, officially or otherwise, shall render the tender liable to be summarily rejected. The tender committee has been empowered to take the final decision regarding the tender.

Amendment of Tender Document:

24. At any time prior to the deadline for submission of proposals, Corporation may for any reason, whether at its own initiative or in response to a clarification requested by a prospective Tenderer modify the Tender Document by issuing an addendum.

Any Addendum issued by the Corporation will reflect in the www.tender.telangana.gov.in / www.tsrtc.telangana.gov.in .

To provide reasonable time to the prospective Tenderers to take an addendum into account while preparing their proposals, the deadline for submission of proposals may be extended, at the discretion of the tendering authority, if required.

Allotment of contract

25. As per the recommendations of the Committee, the contract will be allotted to the successful tenderer. The successful tenderer shall enter into agreement within 15 days from the date of issue of allotment letter of the contract.

Termination of tender process

26. The Corporation may terminate the tender process at any time and without assigning any reason. Corporation makes no commitments, express or implied, that this process will result in a business transaction with anyone.

Signature of the tenderer

GENERAL TERMS AND CONDITIONS FOR INSTALLATION AND OPERATION OF PERSON WEIGHING MACHINES/BMI MACHINES IN TSRTC BUS STATIONS

- 1) Corporation will provide 3' x 3' space in the Bus stations to each Person Weighing Machine/BMI Machine. The successful Tenderer will have to install Person Weighing Machines/BMI Machines only in such Bus stations where the space has been allotted.
- 2) Corporation will arrange to supply electricity to the Person Weighing Machines/BMI Machines installed in the Bus stations. However, all the wiring and material cost from the nearest electric point to the machines, shall be borne by the Tenderer. For each Machine, the contractor shall ensure to fix a sub-meter (with single phase) and "On and Off" switch at his/her own cost. The Tenderer shall pay electricity charges (based on the meter reading) as applicable from time to time for the electricity consumed by the Machines in accordance with revision of tariff by the TSTRANSCO & communicated by TSRTC from time to time. The contractor shall have to pay the Electricity charges on or before 10th day of every month.
- 3) The successful tenderer shall have to execute an agreement with the concerned Regional Managers at his/her own cost, within 15 days from the date of communication of acceptance of his offer - by paying Security Deposit equivalent to 3 highest months license fee per machine. This Security Deposit shall not carry any interest. Failure to pay the Security Deposit amount and requisite stamp duty to enter into the agreement within the stipulated period shall render the EMD amount liable for forfeiture and cancellation of the allotment.
- 4) The Successful tenderer shall install the Minimum Number of Person Weighing Machines/BMI Machines at his own cost within 60 days from the date of commencement of the license period. Failure to do so will entail cancellation of the allotment and the Corporation reserves the right to forfeit the EMD / Security Deposit or both paid by the Tenderer.
- 5) The tenderer / licensee will not be permitted to delete any of the bus stations (once allotted) from the contract. In case the licensee intends to withdraw any bus station, he has to withdraw from the total contract.
- 7) The license period will commence on 16th day from the date of issue of allotment letter to the successful tenderer. However the contractor has to pay the license fee from the date of installation of each Person Weighing Machine/BMI Machine or from 61st day from the date of commencement of the license period whichever is earlier, irrespective of completion of installation of minimum number of Machines.
- 8) The Person Weighing Machines/BMI Machines shall have to be installed at the place / site as provided by the Corporation and the decision taken in selection of site shall be binding on the tenderer. The contractor has to install / shift the machines at his/her own cost / expenses.
- 9) The contractor shall pay license fee (per machine per month), electricity charges etc., on or before 10th day of every month to the Unit Officer concerned.
- 10) The license fee (per machine per month) will be enhanced at 10% every year from 2nd year onwards over the previous year's license fee.
- 11) In the event of delay in payment of monthly license fee (per machine per month), the contractor is liable to pay penalty for each day of delay beyond the due date @ 36% per annum in addition to the monthly license fee payable for the month.
- 12) The contractor shall not deduct TDS from the license fee as the Corporation is exempted from Income Tax.

Signature of the Tenderer

- 13) The contractor shall pay GST @18% or at the rate as fixed by the Govt. of India from time to time, on the contract amount payable to the Corporation, apart from payment of contract amount as agreed to be paid to the Corporation.
- 14) The Corporation shall not be accountable for any loss that the contractor may suffer on account of any damage/theft etc, caused to the Person Weighing Machines.
- 15) The Corporation shall not be accountable for any injury or death caused to the persons using the Person Weighing Machines/BMI Machines nor liable to pay any compensation arising thereof.
- 16) The contractor is responsible and liable for payment of compensation for any injury/death etc., caused to any person due to using the Person Weighing Machines/BMI Machines installed in the Bus station.
- 17) The contractor shall not display any Advertisement/Sign Notice relating to trade on the Machines, except the name of the Company.
- 18) The successful tenderer shall have to obtain certificate or permission or license as may be necessary or required from the concerned authorities of Central Government/State Government/Local Body etc. for running Person Weighing Machines//BMI Machines at his/her own cost.
- 19) The successful tenderer shall comply with rules and procedures laid down in the local/ within the territorial limits in which the business is carried and he shall pay all the Taxes, Fees etc., or other sums payable to the local authorities for the purpose of carrying on the business of installation and operation of Person Weighing Machines/BMI Machines.
- 20) The successful tenderer shall comply with the provisions of all the Acts of Government relating to labour and the Rules and Regulations made there under, from time to time like payment of P.F., ESI, Minimum wages as prescribed by the Govt., of Telangana and submit the proof of compliance. The tenderer shall at all times indemnify the Corporation all claims, damages for compensation under the provisions of all laws and Acts pertaining to the Labour engaged by it.

The successful tenderer shall indemnify the Corporation of any claims made by any authority and reimburse the same in case if any payments are made by Corporation.
- 21) **Corporation shall have the right to permit any other firm/ Tenderer to install Person Weighing Machines/BMI Machines at the Bus stations where the successful Tenderer had provided its/ his machines, on non-exclusive basis.**
- 22) Corporation reserves the right to direct to shift the machine from one site or station to another site or station or any of the machines without assigning any reason and the Tenderer shall have to shift the machines at his/her own expenses.
- 23) If the Person Weighing Machine/BMI Machine is not in working condition continuously for a period of 10 days, a penalty of Rs.500/- per month per machine will be imposed and if it is not working for 15 days continuously, the Corporation reserves the right to confiscate such machine and dispose it off- as it deems fit, treating it as unclaimed item. The contractor shall have to pay the imposed penalty in addition to monthly license fee.

Signature of the Tenderer

- 24) If the contractor fails to pay the monthly license fee for three consecutive months or thrice within the stipulated period/during the course of a calendar year or commits breach of any condition of this Agreement the Corporation shall have the right to take any or all the following actions:
- (i) To forfeit the Security Deposit.
 - (ii) To terminate the contract.

- 25) The contractor shall carry out the business for a minimum period of one year from the date of commencement of the contract.

In the event of the contractor seeking premature termination of contract within the stipulated one year period, the Corporation reserves the right to forfeit the Security deposit duly treating the same as violation of the conditions of the contract.

- 26) The license can be terminated by giving three months notice on either side. In such circumstances, the deposits which may remain to the credit of the successful Tenderer will be refunded after all the dues to the Corporation including incidental financial losses to the Corporation have been settled out of the deposits held.

However, the contractor is permitted to exercise this option only on completion of minimum stipulated period of one year.

Corporation reserves the right to terminate the contract any time during the contract period by giving 3 months advance notice to the Contractor.

In case of any violation of the conditions of the contract the Corporation reserves the right to terminate the contract with one month advance notice.
