- Sealed tenders are invited for the supply of "ZIVA Packaged Drinking Water" in PET Bottles of 250ml", as per BIS specification IS:14543:2016 to deliver at our Zonal Stores/Uppal, Hyderabad and Zonal Stores Karimnagar with TSRTC Label from the Manufacturers of Packaged Drinking Water. The approximate requirements are shown in the enquiry. But it must be distinctly understood that the demands may fluctuate and no definite quantities can be guaranteed.
- 2. The bidder shall have all statutory approvals to run the plant from the respective statutory bodies and shall have approvals as specified by BIS as per product Manual for product (Packaged drinking water) IS:14543:2016 and FSSAI and other statutory permissions including local/district administration/legal metrology.
- 3. The Plant shall be able to supply the required quantities uninterruptedly and shall have:
 - a) Bore well or entry point for the source of raw water, pipeline etc.,
 - b) Raw Water Storage facility.

- 34. The plastic cap i.e., closure of water bottle shall be *embossed* with letters "TSRTC" and the font of the words should be in Times New Roman in size in 21" and shall be in bold letters. Color of the Cap with the Color Apple Green and as per the enclosed bottle Design, label with colour codes design and ZIVA Brand Name.
- 35. Only BOPP label should be used until the end of the contract, height of the label for 250ml is 46.8MM, the thickness of the label is identified between 35 microns to 40 microns.
- 36. The Total Dissolved Solids (TDS) mg/Litre in water shall be 75-150.
- 37. The approved TSRTC Brand Trade Mark is registered by TSRTC with Controller General of Patents, Design & Trade, Department of Industrial Policy & Promotion Ministry of Commerce & Industry, Government of India.

In case the manufacturer conducts re-mineralization as part of treatment process, the ingredients shall be of food/pharma grade quality.
- 43. Shelf life of the Packaged Drinking Water with added minerals in PET Bottles of 250ml should be for a minimum period of 6 months and supplies at our Zonal Stores i.e., HYD/Uppal and Karimnagar, should be made within 1 month from the date of manufacturing.
- 44.In the event of the offered material not being supplied at the appointed time, it is liable to be rejected besides imposing penalty of a sum of equivalent ½ % of value of the delivery scheduled quantity or part thereof subject to maximum of 5% of the scheduled quantity. - 63. Drawings will be provided by the Corporation and they are the property of the Corporation and solely used for the purpose of TSRTC only. Either on outgoing contract or in cancellation of the contract, drawings given for preparation of moulds & cylinders, Moulding instrument & label dye should not be used for any other purpose. In case if the same are used other than the purpose specified above, then legal action will be taken by TSRTC on the firm.
- 64. In case of licence issued to the manufacturer by Bureau of India Standard (herein after called as BIS) expires during the validity of the Purchase order, then it is the sole responsibility of the firm to get the licence renewed immediately from the BIS. At any time during the validity of order TSRTC reserves the right to ask the firm to submit proof of the valid licence issued by the BIS and the firm shall submit the same within 7 days failing which a penalty equivalent to 1% of the scheduled quantity will be imposed on each day delay in submitting the proof of valid licence by the firm upto 15 days. In case the firm fails to submit the valid licence within the above period, the TSRTC reserves the right to cancel the order and forfeit the Security Deposit/EMD of the firm.
- 65.At any time during the completion of order quantity, the TSRTC reserves the right to get packaged drinking water tested (Random samples) at any of the labs approved by BIS OR Labs approved by NABL INDIA(National accreditation Board for Testing and Calibration Laboratories). If the same fails to qualify in the above test, the penalty of a sum of equivalent ½% of the value of the order or part there of subject to maximum of 5% of the order value shall be levied on the firm including recovery of testing charges from the payable bills.
- 66. The successful bidder shall have to maintain at all times, the quality standards as per
